In recent NIS Study Days on curriculum development and user education, much of the emphasis has been on support for preregistration students on Project 2000 courses. This Study Day aims to turn the focus on to continuing education. The introduction of PREPP and the ENB's Framework and Higher Awards will pose many new challenges for librarians and tutorial staff, as well as for the clinical staff involved, some of whom may not have studied formally for many years.

Continuing professional development has also become a topical issue for the library profession, with the recent launch of the Library Association's own Framework and Personal Profiles. It is hoped that a display of professional literature and material on relevant short- and long-term courses will be available.
