This provides the full reference details, including the details of the journal that has published the trial. Also provided are details about the method of the trial or review, information about the scores, details about whether the eligibility criteria have been supplied and a rating status. An abstract is included if copyright permission has been granted.

It is possible to print or email the full record, or results can be marked and emailed as a batch. The option to further refine your search is also available.

The other sections of the service relate to: information about the database; links to Frequently Asked Questions; a tutorial providing information about EBP, systematic reviews and RCTs; acknowledgements of organisations that have assisted with the database; contact details and links to other Evidence-based websites and services.

Overall, the service looks to provide useful and good quality information for occupational therapists and will add to the resources such as PEDro, Cochrane Database of Systematic Reviews and DARE that already provide access to appraised and evaluated studies.
